Building and Code Enforcement Report- Warren Wisneski

Holland Road, warrants have been served court date as of now is September 20th. Slow progress has been made but some is being done. Would like to talk to council about adopting E&S code and Maintenance Code. Most states and counties have already adopted these.

Made aware of situation on pet pigs according to town code written that no hog farms or pig fattening will be allowed. Should amend code to allow with restrictions for pet pigs and include enclosures being sanitary and have proper vet care.

Reviewed NFP resolution, I have done a breakdown of the resolution the cause and effects of flooded areas. If adopted a yearly report is required to be submitted that is fairly easy.

Discussion-

Rita Berger- Cannot get flood insurance without the town passing the resolution.
