Meeting Purpose- Council Seat Vacancy

Statement form the Mayor-

Why are we here tonight? Let me answer that.

At our last meeting, some members of the public questioned why we needed to hold a special election when our charter states that "Vacancies on the council shall be filled for the unexpired portion of the term by a majority vote of the members of the council". This was all well and good until 2010.

In the 2010 session of the General Assembly, two bills were passed that altered the procedure for filling vacancies within a city or town council or county board of supervisors. The effect of the changes differed depending on the size of a locality, with a greater impact on towns with a population of less than 3,500.

Towns with a population of less than 3,500 were previously exempt from a requirement to hold a special election if an elected position became vacant, so long as the remainder of council made an appointment within 45 days of the vacancy. The changes to the law remove this exemption, requiring these towns to hold a special election after appointing a replacement.

VA Code 24.2-228 states in part: "Notwithstanding any charter provisions to the contrary, the person so appointed shall hold office ONLY until the qualified voters fill the vacancy by special election pursuant to 24-2-682 and the person so elected has qualified".

Therefore, since special elections are very costly (our May election cost \$1900) we have petitioned Judge Lewis to hold our Special Election to be held as part of the 2019 general election on November 5, 2019 whereby the Town's cost will be only \$200 to \$300.

But, before Judge Lewis will consider our request he wants the Town to meet the 45 day requirement and appoint someone to replace the vacancy on our Council.

The 45<sup>th</sup> day is November 10<sup>th</sup> so that is the reason for this Special Called Meeting to fill the vacancy. The person appointed by the Council shall serve until the Special Election which hopefully will be held on November 5, 2019. The person elected on November 5, 2019 shall serve until January 1<sup>st</sup>, 2021 to fill the remainder for the unexpired term of Mr. Travis.

Mayor LeMond Asked all parties interested in the position to speak, Jason Van Marter and Bruce Nutter were present, Scott Berger and Greg Hardesty were not present but sent statements for Clerk Stacey Sparrow to read into the record.

**Jason Van Marter**- I am still new to Cheriton but have been connected to Cheriton for 13 years. My wife was raised in Cheriton and stories of her childhood prompted us to move here to raise our children in this town. I have started a business in Cheriton and love Cheriton. I feel I can offer fresh new ideas to Cheriton. I will continue to support Cheriton even if I am not appointed to this position and plan to have my name on the ballot for the next election.

**Scott Berger**- Letter read by Clerk Stacey Sparrow

*Mr. Mayor, Town Council members, thank you for the opportunity to express my interest and desire to be considered for the vacant council seat. I regret I cannot be there with you tonight, as I am in Richmond for the state's annual architectural conference. **Gregory Hardesty-** Letter read by Clerk Stacey Sparrow

*I made this move 12 years ago, moving back to Cheriton, working with my Pop, Vernon Lewis, raising clams for Cherrystone Aqua Farms as a member of their co-op.*

*Since returning home, the majority of my time is made up of helping to run the family business and assist my parents in whatever they may need. Throughout this time period, I've also served 2 terms on the Cheriton Town Council, one as a member on the Public Service Authority, and also help work Bingo for CVFD as time permits.*

*On a personal note, over the last previous year, I experienced a minor health issue which affected many facets of my life, which partly explains my relative absence of public service. I'm pleased to say that I'm again at full by the grace of god. Presently ready to be of any service I can assist with.*
